Thank you for your freedom of information request received in this office on **16 July** 2024 in which you asked:

'International Store based on the Erdington High Street was served with a Closure Order, after a Alleged serious Racial Assault on a Pregnant female, a Schoolboy and two other individuals who required Hospital treatment; Could we request a Copy of this Closure Order Obtained by the Police, to reassure the community that this Order Exists.

*On the 15th June, the shop was visually open, goods displayed illegally on the public Right of Way .
How is this shop being Monitored by the Police and LCSP after such a serious incident, Why is it still Trading.*

*Could West Midlands Police confirm if they have Objected to any Licensing of shop premises along the Erdington High Street in relation to Opening hours/Alcohol licenses of Premises.
If you have Not, could you provide reason with the growing dangers members of the public and School children face daily. Could you also provide details of who holds Legal Authority to Object.*

What actions can West Midlands Police take against non Compliance of a Closer Order and who has the Authority to take Action.'

Freedom of Information Right of Appeal

All requests for review will be recorded. Receipt of a request for internal review will be acknowledged and the appellant informed of an estimated date for determining the outcome. The OPCC will attempt to respond to internal reviews as soon as practicable and in any case within two months.

All investigations will be undertaken by someone not involved in the original response.

The result of any internal review will be communicated to the appellant outlining the decisions taken.
