POLICE AND CRIME PLAN - PROGRESS AND KEY PRIORITIES

1. PURPOSE OF REPORT

1.1 To provide members of the Committee with an update regarding the development of the Police and Crime Plan (PCP) 2025-2029

2. POLICE AND CRIME PLAN REQUIREMENTS

- 2.1 The Police Reform and Social Responsibility Act 2011 requires the Police and Crime Commissioner (PCC) to publish a Police and Crime Plan to cover their term by the end of the financial year in which they are elected. It stipulates that the plan must contain:
 - Reference to the Strategic Policing Requirement
 - Police and crime objectives
 - Financial and other resources for the CC
 - How the CC should report to the PCC
 - How CC/Force performance will be measured
 - Detail of crime and disorder reduction grants
- 2.2 In creating the PCP the PCC must:
 - Consult the Chief Constable in preparing the draft plan
 - Send the draft plan to the Police and Crime Panel and have regard to recommendations they may make

3 PROCESS FOR DEVELOPING THE PCP

- 3.1 In order to deliver on the above requirements a Project board has been stood up to oversee the development and publication of the PCP. This is chaired by the Chief Executive as project sponsor, with the Deputy Chief Executive acting as vice chair. The project manager and lead writer of the plan is the Head of Policy with a wide variety of staff from across the organisation collectively delivering the project. Financial oversight of the project is given directly by the Chief Finance Officer.
- 3.2 The PCC and Deputy PCC are routinely engaged to ensure the plan is aligned to their wishes.

3.3 The PCP has been developed in line with the timeline at figure 1. This initially involved the creation of a needs assessment which has supported the PCC in developing a "plan on a page" which sets out the PCC's priorities and principles. We are currently in the consultation phase.

- 3.4 The needs assessment itself included the following data from Police systems, Office of National Statistics, NOMIS (Census and labour market statistics) and Action Fraud:
 - Custody
 - Investigations
 - Force contact
 - Workforce and specialist skills
 - Victim and suspect profiles
 - Crime/harm data
 - Seasonality profiles
 - Engage performance
 - Policing powers

4 PROCESS FOR DEVELOPING THE PCP

- 4.1 The PCC's plan on a page is attached at appendix 1 and sets out the following high-level priorities:
 - Rebuild community policing
 - Tackle violence
 - Improve road safety
 - Reduce neighbourhood crime
 - Protect victims and witnesses
 - Make West Midlands Police excellent

And the following principles:

- Bringing offenders to justice
- Prevention and rehabilitation
- Partnerships
- Building trust and confidence

5 PROCESS FOR DEVELOPING THE PCP

A consultation process is currently being undertaken to allow the public and wider interested stakeholders to give their thoughts on West Midlands Police, the priorities and principles as set out in the plan on a page and more generally what they think ought to be covered in the Police and Crime Plan. We are taking a mixed approach to consultation seeking to access as wide engagement as possible as set out in our consultation matrix at figure 2 below.

We are keeping track of demographic and geographic engagement with our consultation so as to be able to take a targeted approach within the second half of the consultation period to ensure we have a representative sample. Our targeted approach will include:

- Consideration of which additional events we could attend
- Use of Community researchers
- Targeted social media advertising of our survey
- Engagement with partners/stakeholders with existing links with under-represented groups

Members of the committee should have already received our call for evidence, including the opportunity to fill in our survey. The QR code to access the survey is below should any members still wish to fill it in.



Alongside the public consultation we are also undertaking ongoing engagement with the Chief Constable and the Police and Crime Panel. They will also be formally consulted on the draft plan towards the end of November and start of December which will allow publication to take place in February. This allows 1 month's slippage if required in terms of the statutory deadline.

6 NEXT STEPS

We are starting to build the content of the PCP internally, feeding in different inputs as they are submitted. We will then go through a refining process before creating the draft plan itself and progressing in line with figure 1 above and ensuring that it fully aligns to the requirements set out at section 2 above.
